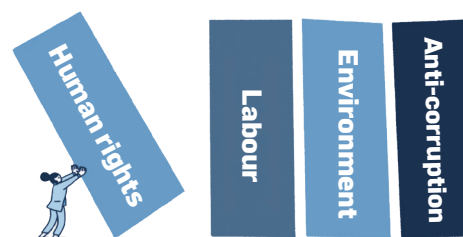

WHY SHOULD YOUR COMPANY JOIN THE UNITED NATIONS GLOBAL COMPACT – THE WORLD'S LARGEST RESPONSIBLE BUSINESS INITIATIVE?

The United Nations Global Compact is an integral part of the UN system, headquartered in New York, operating in over 160 countries and bringing together more than 25,000 participants.

It is the world's largest initiative bringing together businesses committed to sustainable development, launched by the UN Secretary-General in 2000. It unites companies working in line with the Sustainable Development Goals and the Ten Principles of the United Nations Global Compact, which cover four areas: human rights, labor standards, environmental protection, and anti-corruption.



Why Join the UN Global Compact?

10 PRINCIPLES of the UN Global Compact

HUMAN RIGHTS

- 1 Businesses should support and respect the protection of internationally proclaimed human rights.
- 2 Make sure that they are not complicit in human rights abuses.

LABOUR

- 3 Businesses should uphold the freedom of association and the effective recognition of the right to collective bargaining
- 4 The elimination of all forms of forced and compulsory labour.
- 5 The effective abolition of child labour.
- 6 The elimination of discrimination in respect of employment and occupation.

ENVIRONMENT

- 7 Businesses should support a precautionary approach to environmental challenges.
- 8 Undertake initiatives to promote greater environmental responsibility.
- 9 Encourage the development and diffusion of environmentally friendly technologies.

ANTI-CORRUPTION

- 10 Businesses should work against corruption in all its forms, including extortion and bribery.
